PSEC POLICY AND PROCEDURES

SELECTION OF ARTWORKS FOR THE AWARDS

JURIED EXHIBITION "LES PASTELLISTES" AND MEMBERS' CHOICE EXHIBITION "PASTEL TOUJOURS"

POLICY

When organizing an exhibition, whether the juried exhibition "Les Pastellistes" or the members' choice exhibition "Pastel Toujours", PSEC must form a jury of **judges for the awards**¹. The judges may only choose one award per exhibiting artist.

Please note that the number of awards given will vary according to the sponsorships obtained.

PROCEDURES

To select the award-winning artworks, the jury will proceed as follows:

- On the morning of the opening day of the "Les Pastellistes" show, the President of PSEC or the person
 responsible for the exhibition meets with the judges of the awards at the gallery where the exhibition
 is being held. As "Pastel Toujours" is generally held in varying regions, arrangements will be made as
 needed between PSEC and the judges.
- Prior to the judges' arrival, the artists' signatures on the artworks, as well as on the identification cards are blanked out;
- The judges are given the document "Criteria for Analysing an Artwork². This document reminds them
 of the importance of remaining objective and open minded towards the different themes and styles of
 the artworks and lists some academic criteria to be considered.
- The judges are given a list of all the artworks in the show. Only the identification number and title of the paintings are shown on this list.
- They receive a grid listing the various categories of awards to be given³. They will individually make a first round of the works and take notes;
- The judges make a second round looking at the artwork on their own, reflecting on the various choices;
- They will then meet and discuss their respective choices;
- When the judges reach a unanimous decision, it is the responsibility of the PSEC representative to
 ensure, by consulting the confidential list of the artists' names, that they not award more than one
 prize to the same person. Should this be an issue, the judges are asked to modify their choices and
 come to a consensus;
- The PSEC representative present during the process should make sure to avoid comments which could
 influence the judge's decisions. However, the judges may be asked for justification to support their
 choices.
